### Contributions to a Hawaii Gubernatorial Race

Hawaii law governs campaign contributions for state and local races.

- For the gubernatorial race, aggregate contributions cannot exceed \$6,000 per person during an election period. The election period for the 2018 gubernatorial race is Nov. 5, 2014 through Nov. 6, 2018.
- Contributions from individuals must be made from their own funds, and not funds from another.
- Anonymous contributions are prohibited under the campaign spending law.
- Contributions from state and county contractors are prohibited.
- Contributions from foreign nationals are prohibited.
